GCC Business Majors (ABus-GR)

The Associate in Business General Requirements (ABus-GR) degree is designed for students who plan to transfer to Arizona's public universities into majors that articulate with the Associate in Business General Requirements pathway and for students who plan to complete lower division course work toward a baccalaureate program at other degree granting institutions. All business majors except Computer Information Systems should follow the ABus-GR pathway. Computer Information Systems majors should follow the Associate in Business Special Requirements (ABus-SR) pathway.

Generally, the degree transfers as a block without loss of credit to Arizona's public universities and other institutions with district-wide articulation agreements. In most cases, courses used to satisfy the MCCCD Associate in Business General Requirements will apply to university graduation requirements of the university major for which the ABus-GR was designed.

The ABus-GR degree is a transfer pathway for the following Bachelor of Science degrees in Business with the following Majors:

- Accounting
 Finance
 Economics
 Supply Chain Management
- Marketing
 Management
 Business Administration

It is also a pathway to Bachelor of Arts degrees in business and other university specific business programs.

The ABus-GR degree is designed for students who plan to transfer to Arizona's universities into majors that articulate with this degree pathway. The ABus-GR degree will be accepted by the business-degree programs at specified Arizona public universities and other institutions with which GCC has transfer agreements, i.e., the degree transfers as a block without loss of credit.

All business majors (except Computer Information Systems) should follow this pathway. Students are responsible for proper selection of courses and admission into university and professional programs. Other transfer pathways and course sequences exist. Please discuss these options with your advisor. The courses listed need to be completed with a grade of 'C' or higher. 

ACC111, GBS151 and CIS105 should be among the first ABus courses taken. The solid arrows in the flowchart represent required prerequisites. The dashed arrows represent suggested, but not required prerequisites. The A-BUS courses not listed above may generally be taken in any order.

To enroll in ENG101 or MAT212, you may need to take English or math prerequisite courses. Take the ASSET or ACCUPLACER test, and then see an advisor for details to see if prerequisite courses are required. Most A-BUS courses can be taken even if prerequisite English and math courses have not been completed.
